

Planned venue will be the function room at the Ted Burge complex, South Wentworthville. This will be confirmed along with times. The training will be run by NSWCU&S in conjunction with PDCUA. TREASURER'S REPORT

The 2020/21 season has seen our account balance remain stable – decreasing over our opening balance by \$898.91.

Our main income sources were membership payments of \$6,180.00 and Umpiring/Training Fees received from Parramatta District Cricket Association (PDCA) \$34,595. Our main expense was umpiring fees for members who officiated in both PDCA Domestic competitions and also the Inter District representative competitions.

We would like to thank Frank Pitt and Madan Alagaraja from PDCA for their continued support and patience over this year and their prompt payment of all invoices that we issued. The Committee of the PDCUA also wish to express our thanks to the Board of

PDCA for their work in securing the agreement of PDCA member clubs to support the Training Levy system imposed this year to assist PDCUA with umpire development.

We have changed some aspects of how we administer the running of the PDCUA such as development of the PDCUA website and on-line self-assessment reporting. This resulted in PDCUA incurring costs developing and licencing the website. We also incurred costs due to Covid restrictions necessitating Zoom subscriptions for meetings whilst lockdowns were implemented. We have also had to upgrade our laptop as the old machine was obsolete – selling this machine for \$341.00 and replacing it at a cost of \$1,208.95. These capital and 1 off costs have contributed to the losses incurred this year.

We have also had to pay \$875.00 PDCA umpiring fees due for the 2020/2021 season as we finally received the required documentation to support that payment.

Overall our financial position is sound as a number of larger item expenses incurred this year should not be recuring costs moving forward.

I hope you all had an enjoyable season and will be back next year.
