

Due to Covid the usual umpire training had to be cancelled. The next training is scheduled for August '21, venue, dates and times TBA. The training will be run by NSWCU&S in conjunction with PDCUA. We usually pick up several new umpires from this training. Anyone interested in attending are welcome but numbers are limited. Thanks goes to the appointments committee ably led by Chairman John Kennedy who often had to rearrange appointments due to last minute drop-outs. Overall, we generally met our commitment of having a black and white appointed to the top 3 grades, A - B1 and in some instances supplied 2 umpires to various grades. Having a 2^{nd} umpire was seen as a way of promoting umpires through the grades with the extra fees covered by both PDCA and PDCUA.

Our season was cut short at the front end due to the Covid virus with round 1 starting on 17/10/20. The junior competition consisted for the first time of 17 one day matches whereas the senior comp had 14 rounds with a combination of 2-day, 1-day and 20/20

matches. The semi-finals were washed-out, so the top 2 teams progressed straight to the final. Congratulations to the winners.

TREASURER'S REPORT

The 2020/21 season has seen our account balance remain stable – increasing slightly over our opening balance. Given we still owe \$875.00 in umpiring fees at the date of this report our actual balance is significantly lower than the \$10,079.23 shown (\$9,204.23).

Our main income sources were membership payments of \$4,650 and Umpiring Fees received from both Parramatta District Cricket Association (PDCA) and Norwest Hurricanes (NWS). Our main expense was umpiring fees for members who officiated in both PDCA Domestic competitions and also the Inter District representative competitions.

We would like to thank Frank Pitt and Madan Alagarraja from PDCA for their continued support over this year and their prompt payment of all invoices that we issued. We also thank Steve and Cheryl from NWS who also paid their invoices promptly. The

Committee of the PDCUA also wish to express our thanks to the Board of PDCA for the \$4,000 grant they have made to PDCUA to assist us with umpire development.

I would also like to thank both PDCA and Norwest Hurricanes for their patience given there were numerous teething problems with the new appointments processes this season which led to invoicing issues. I appreciated their patience as we resolved these issues which at times necessitated fresh invoicing.

I hope you all had an enjoyable season and will be back next year.
