### PRESIDENT'S FOREWORD

The ongoing Pandemic will impact on our end of season functions and meetings. The Presentation will not be held and AGM will be postponed and a start date for the 2020/2021 season is unknown. The Covid-19 will change how we do things including how we shine the ball!

The competition numbers remained strong overall. Seniors and the younger juniors had many teams, but the upper junior grades (U15 & U16) were again lacking in depth. Hopefully we can find a way to increase numbers in theses ages. The depth of the A Grade competition also remains an issue. The season had a wide range of weather with the extreme heat and total washouts within a few weeks in early 2020.

Congratulations to those teams who were premiers. Whilst nobody wants to win the competition without playing a final, the teams who won were higher placed, based on the season long results. Congratulations to Baulkham Hills on winning the A Grade Premiership, their first since 1995/1996.

The competition structure continues to evolve, in line with Cricket NSW policies. Stage 2 will extend to U13 in 2020/2021 and Stage 3 may be progressively introduced over the upcoming seasons.

The PDCUA continues to provide umpires for both senior and junior games. Their numbers for the finals were strong, with all grades scheduled to be covered for the finals. Thanks to President Rob Dryburgh, Secretary Ken Bakon and Treasurer Terry Heath and their committee.

Our clubs do a great job in providing cricket for all ages and we thank the committees for their efforts.

The Pandemic meant the Board held its first virtual meeting in April. It was an interesting experience. The Board has evolved over the last few years with new members joining, but it continues to work well running our competitions.

Our Executive Officer Frank Pitt has again run the Association seamlessly this year. It is a big job and I thank Frank for his efforts. Our Financial Officer Barry Twining has managed the Finances this year, as he has done over many seasons. Barry has been a magnificent servant of PDCA for close to 50 years. The Judiciary and Competition Committees both ran well under the Chairmanship of Michael Johns and Cameron Laurie respectively. Thanks Michael and Cameron and those who assisted on both these committees.

I look forward to season 2020/2021 and hopefully we can get on the field as soon as possible. Stay safe.

# **EXECUTIVE OFFICER'S REPORT**

What can be said about PDCA's 2019-20 season? It was certainly unusual, and those things that impacted on our cricket serve to show how fortunate we are when we can take the field for Saturday sport. While the fires and the pandemic interrupted cricket in Parramatta, some people's lives and livelihoods, homes & security were lost, and our thoughts and best wishes are with them. Perhaps just being able to play may be more important than who wins next time we walk on.

When we play again it will be due to the dedication and hard work of our various club's and the association's volunteers. As always, they deserve our thanks and support, as well as each player or parent asking "How can I help?", and perhaps finding that they can.

I would like to thank all those who participate on the various committees of PDCA – Competitions, Judiciary, Grading and Representative Committees and of course, the Board. Each season we call for help with these bodies and welcome all enquiries. The Parramatta Umpires Association were again a great assistance to our competition, I thank all their officers & members.

Parra's representative teams performed extremely well in 2019-20. We entered teams in all the competitions available; 9 teams in the Cricket NSW Youth Championships where 8 made it to the final four of sixteen and two teams won this very competitive championship. 7 teams entered the IDCA President Cup Competition, with two finishing as Champions. Our all-age men competed in the DCA Martin Shield and were runners up. Such a wide-ranging campaign is only possible with the help of many people, most of whom are mentioned in the following individual team reports. I would like to specifically thank Justin Isaacs, for his efficient and successful President Cup management.

The 2019-20 PDCA season began with an increase in participation in both junior and senior cricket. Stage One participation increased by one competition with expansion of the girls Thunder League. Competitive junior comps remained at ten, with the under 12 boys moving to the Stage Two format. Senior comps grew by one to 17. A combination of growth and the withdrawal of some grounds by councils resulted in too few grounds to allocate on the usual "home ground" basis. Some junior matches had to share grounds by playing back to back, some teams found themselves far from home in unfamiliar territory and some teams played every match "away". I can only see this situation becoming worse, and ask that we all - clubs, players and parents - let the local councils and our councillors know about it.

Team grading continues to set challenges with some very accomplished cricketers not wishing to test their skills in an appropriate grade. I thank the Grading Committee of Barry Twining (Chair), Peter McLoughlin and Michael Johns for their time and often intense efforts in putting our competitions together in a tight time frame. Most grades appear to have had close contests for the final four, however, it is clear that the top few grades, particularly A Grade, remain uneven and require some innovation.

A few early round matches were affected by rain but our season progressed pretty well through the midpoint when things turned decidedly weird. Bushfire smoke, extreme heat and rain had an impact on rounds ten, eleven and twelve. We moved into the finals short of grounds due to soccer's demands on councils, but hopeful the deciders would play out on the parks and reveal proven victors. While rain marred both days of the semi-finals almost all of these matches went to a result. Then history happened and our season ended with a phone call and premierships were decided on the ladder positions of the semi-final winners. I know I speak for many when I say that to compete in a Grand Final is a rare honour and to have played and lost would be preferable to never knowing how the "Big Dance" might have gone.

Congratulations to the 2019-20 premiers in each division, and good luck to all for 2020-21.

# **COMPETITION COMMITTEE**

(Cameron Laurie - Chairman)

Season 2019-2020 has provided one of the most unusual finishes, all the grand final winners being decided by a virus. COVID-19 was not the only reason we had games stopped, extreme heat and bush fire smoke put in their two bob's worth.

I recently read a media release that discussed the ups and downs of cricket participation across the greater Sydney area, some associations have almost collapsed, one association was highly praised for their huge numbers, especially their growth in junior ranks.

PDCA passed this other area by 46 teams, we fielded 121 senior teams (up by 10) 139 junior mixed teams (up by 16) and 12 girls only teams (up by 5).

Frank Pitt deserves a huge thanks for his efforts in making all these extra teams fit into an already bulging competition, how he continues to find grounds is amazing; with the continuation of stage cricket next season Frank will a very busy executive officer.

All the cricket clubs have again given the PDCA great support, the growth of our game shows that the hard work from the club officials and volunteers is continuing to make us a strong and viable association, thank you on behalf of the PDCA

Late registrations have become a part of our game, but as time becomes a harder thing to find, teams will always need those valuable fill-ins to get the right number on the park each week.

Player umpires did their job and very few games were left without an umpire, thanks to all the clubs who fulfilled their commitments. The Black and White umpires grew in numbers and more games were covered, which is valued by the players, the PDCA thanks and appreciates the PDCUA for their contributions and support.

Congratulations to all the teams who won their premierships in the PDCA competition, the number of representative teams grew with the introduction of the IDCA competition, a full report is included in a separate report.

The judiciary committee was kept busy with many multiple hearings during the season, players have continued to cross the line in the sand and have yet to realise that a zero tolerance is in place. The full details of these meetings can be read in a separate report.

The members of the competition committee welcomed some first timers, who all made important contributions the running of the game; we give our thanks to the following people, Madan Alagarraja, John Kozumplik, Ashwath Krishna, Frank Pitt, and Tapan Sharma

Lastly the committee thanks the PDCC and the PDCA Board for its ongoing support.

# JUDICIARY COMMITTEE

(Michael Johns – Chairman)

From a Judicial perspective the season started off pretty slowly after a torrid previous season. When the warmer weather kicked in, we had numerous reports mostly for players simply disrespecting the umpires, the opposition and our code of Conduct.

The list below is of the players who appeared and were found guilty of breaches of our Code of Conduct. There were a few other reports where a warning was sufficient. Very disappointingly there were a few reports from both Clubs and Umpires on Junior Coaches and players. We ask the Clubs to ensure Junior Coaches stay within acceptable Social boundaries and also our Code of Conduct The Junior age players are all spoken to by myself as Judiciary Chair and for first offence are simply reminded of their obligations under our rules - they are not named here for obvious privacy concerns.

The Judiciary will continue to support our umpires so the message to all players is to please remain playing within our rules, within our Code of Conduct and set a great example of the Spirit of Cricket within PDCA.We are currently working on reviewing our processes for next season but honestly hope not to see any players appear before the panel.

Thanks are extended to those that sat on the panels namely Doug D'Arney, Cameron Laurie, Eric Myatt, Paul Giumelli and Scott Riebelt and Frank Pitt.

**Zorawar Singh** from Kings Langley B9 was suspended pending an ID check and re-registration (late rego) process being applied - his team was penalised all competition points for the matches he played as an unqualified player

**Mahiban Rajendram** of Sydney Supersonics B11 was guilty of a breach of our Code of Conduct - he is suspended from playing until 31/12/19 and the team penalised 5 Competition points

**Paramjit Singh** of PTW B11 is guilty of a breach of our Code of Conduct - he is suspended from playing until 31/12/2019 and the team penalised 5 Competition points

**Brenton Butcher** from Guildford Leagues A Reserves is guilty of a breach of our Code of Conduct - he is to be suspended til 31/12/2019 and his team penalised 5 competition points

**Harjeet Sain**i Kings Langley A Reserves player is guilty of a breach of our Code of Conduct - he is to be suspended until 31/12/2019 and his team penalised 5 competition points

**Michael Norford** from Baulkham Hills B4 is suspended for 4 playing dates for dissent and the team penalised 5 competition points

**Karthik Padmanabhan** from Cheetahs B14 has been found guilty of a breach of our Code of Conduct suspended for 2 playing dates and the team penalised 5 competition points

**Dan Fletcher** from Seven Hills Toongabbie RSL B15 is guilty of a breach of our Code of Conduct and is suspended for 6 playing dates and loss of 5 competition points

**Mohan Akkinenei** from PTW B15 is suspended for 2 playing dates and loss of 5 points (overturned on appeal after 1 match suspension served)

**Daniel McMaster** from Kings Langley A Grade captain has breached our Code of Conduct and was suspended for 1 playing date and the team penalised 5 points

**David Hossack** from Rouse Hill Rams A Reserve is guilty of a breach of our Code of Conduct - he is suspended for 2 playing dates and the team penalised 5 points

**Vincent Fernando** from Indian Cricket Club is guilty of a breach of our Code of Conduct. As Captain, and despite being penalised for a similar incident earlier in the season, he knowingly played unregistered and unqualified players. He further contributed to the breach by recording the scores of unqualified players in MyCricket under different players names. He is to be suspended from Cricket until the conclusion of our 2021/22 season - effectively a 2 year ban.

He was informed that PDCA will not accept his registration in any competition going forward - effectively a life ban from PDCA.

**Siddharth Dinde** from Indian Cricket Club B6 is guilty of a breach of our Code of Conduct. He knowingly played when he was unregistered and unqualified. He is to be suspended from Cricket until the conclusion of our 2020/21 season - effectively a 1 year ban.

**Prapul Beeraka** from Indian Cricket Club is guilty of a breach of our Code of Conduct. He knowingly played when he was unregistered and unqualified. He is to be suspended from Cricket until the conclusion of our 2020/21 season - effectively a 1 year ban.

# PARRAMATTA DISTRICT CRICKET UMPIRES ASSOCIATION

The PDCUA continue to support our junior and senior competitions, appointing qualified Umpires to stand in our all higher grade matches as well as circulating through each lower grade periodically. The Umpires Association's membership increased for 2019-20 after a well-attended off-season training course, the strength of the association is testament to the hard work of its officers Doug D'Arney (President), Ken Bakon (Secretary) and Terry Heath (Treasurer).

New members can gain qualification at the annual Parramatta training course, or others run by Cricket NSW both in person and on-line. Coaches, Managers, Captains and players are encouraged to participate in one of these courses and learn the Laws of the game they play or manage. Once qualified, joining the association can provide an income when not playing, from the best seat in the house.

It was with shock and great sadness that our cricketing community learned in May of the sudden passing away of Terry Heath. All who knew Terry will agree that he was a thorough gentleman and great servant of the Umpires Association and cricket. Those umpires fortunate enough to have paired with Terry, and players in matches he umpired over many years, would attest to his calm, considered adjudication and skill as an umpire. We are poorer for his passing; our sympathy and condolences go out to Terry's family.

The Umpires Association Annual Report follows separately.

### **SPONSORSHIP**

Our Association enjoys substantial financial support from Kookaburra, which effectively lowers the cost of participation for every player. That support deserves our appreciation and thanks. We also receive support from Kingsgrove Sports. Again, this is appreciated and should be considered by all our members when in need of new cricket gear or any sporting equipment

# FINANCIAL OFFICER'S REPORT

The purpose of this report is to explain various items of Income and Expenditure listed in the Financial Statements.

Insurance - Juniors:

Cricket NSW via My Cricket assumed control of Player Insurance payments in respect of Juniors. Consequently, zero Income is shown for this item. Expenditure on Player Insurance is similarly reduced. It is anticipated that Senior Player Insurance may be similarly dealt with from next season.

#### **Ground Rental:**

The reduction in Income and Expenditure is a result of some Council charges being delayed until after 30 April 2018 and thus increasing the amounts recorded in 2018/19 season.

Inter Association Clothing and Fees:

Cricket NSW took control of Junior Representative Cricket from NSWDCA and Player Fees were introduced to cover match expenses (grounds, umpires, balls etc) and clothing. Expenses pertaining to Watson and Martin Shields were still incurred separately.

#### Government Grant:

A one-off Sports Grant of \$6,000 was received from the NSW Government.

#### Pink Stumps Day:

Clubs raised \$13,700. PDCA supplemented this by \$1,300 resulting in a donation of \$15,000 to the McGrath Foundation.

#### Scorebooks:

NSWDCA ceased providing Scorebooks for sale.

### Sponsorship:

Kookaburra Sports have been most generous sponsors of PDCA. We anticipate they will continue their sponsorship but given the current economic conditions we expect it will be limited to the agreed \$10,000 per season.

#### Umpires' Fees:

An amount of \$3,690 relating to Umpires' Fees unpaid at the end of 2018-19 is included in Umpires' Fees received. An amount of \$2,065 is unpaid for 2019-20. This is listed in the Statement of Assets and Liabilities.

#### Administration Grants:

The reduction in expenditure relates to July/August 2018 when additional cost was incurred during the succession process of the Executive Officer.

#### **Donations:**

As mentioned above \$15,000 was raised for the McGrath Foundation.

A contribution of \$1,500 was made to the Parramatta District Cricket Club.

# PDCUA Contributions:

An additional \$2,000 was contributed towards Umpire training.

#### Financial Status:

PDCA finances are in a healthy state with a bank balance of \$97,691 at season's end. Normal off-season expenditure for administration and trophies should result in a balance of approximately \$80,000 to start the 2020-21 season.

It is expected all sporting bodies will face challenges in the coming year as a result of the economic conditions prevailing from the pandemic.

Being in a healthy position may enable the Association to ease the burden on the clubs in some way.
