

Overall, we generally met our commitment of having a black and white appointed to the top 2 grades, A and A(Res) and in some instances supplied 2 umpires to various grades. Having a 2nd umpire is seen as a way of promoting umpires through the grades.

The junior competition consisted of 13 rounds stage 3 with a combination of 1 and 2-day matches and Junior stage 1-2 had 19 rounds with one day matches whereas the senior comp had 14 rounds also with a combination of 1-day, 2-day matches.

The end of season dinner and awards night was held in late March with the following gentlemen taking the various awards.

We had 88 umpires registered this season (86 paid up members and 2 life members) - including 14 new members.

The PDCUA Executive would also like to thank our members who have committed their time to umpire across all relevant competitions on both Saturdays and Sundays, and also those members who lodge their self-assessment reports in a timely manner as this really does assist in invoicing and reconciliation.

The 2022/23 season has seen our account balance reduce by \$3,161.84.

Our main income sources were membership payments of \$5,920.00 and Umpiring Fees received from Parramatta District Cricket Association (PDCA) \$68,010.

Our main expense was umpiring fees for both PDCA Domestic competitions as well as the Inter District representative competitions – totalling \$72,510. We also incurred new uniform expenses of \$2,142 as an extraordinary outgoing.

We acknowledge and thank Cricket NSW for their \$1,000 grant to PDCUA.

We also acknowledge and thank PDCA for their \$830 contribution towards the "Double-Up" costs incurred by PDCUA for the 2021/22 season.

We would also like to thank Frank Pitt and Madan Alagaraja from PDCA for their continued support and patience over this year as we again have had numerous reconciliation issues with umpire appointments and attendances, and delayed lodgements of self-assessment reports.

Although we still have a relatively healthy bank balance overall our financial position has worsened significantly during this season due to the need for new shirts and jackets and a significant loss from training and "Double-Ups". The Executive are currently working with PDCA to formalise these training and Double-Ups issues to reduce this cost to PDCUA.

I hope you all had an enjoyable season and will be back next year.
